Exhibition Rules and Regulations

LIABILITY: Upon approval of this contract by an authorized Marketplace 2017 Representative, it is expressly understood that the Vendor has read and agreed to abide by the TNLWP liability policies outlined below:

The Toronto New Life Wellness Place Inc., hereinafter referred to as TNLWP, and all organization and individuals who are employed by or associated with it, in connection with the **Holiday Arts & Crafts Marketplace 2017**, will not assume responsibility and shall be held harmless by all vendors for damage or loss resulting from fire, theft, or any other cause whatsoever, including accident or injury to Exhibitor, their employees and agents, the public, or others. The Vendor agrees to pay promptly for any and all damages to the exhibition building/venue or its equipment incurred through carelessness or otherwise, of Vendor or its employees or agents.

LOCATION: TNLWP reserves the right to determine final placement of the Vendor within the designated facility.

TRANSPORTATION/SETUP: All transportation costs, and any other costs related to exhibit setup not explicitly offered above by TNLWP, are to be paid by the Vendor.

LOSSES: TNLWP will not take responsibility for damage to Vendor's property or lost shipments either coming in or going out, nor for moving costs. Damage to inadequately packed property is Vendor's own responsibility. If exhibit fails to arrive, Vendor is nevertheless responsible for the exhibit space reserved as per this contract. TNLWP cannot be held responsible for loss or damage to any Vendor's property. Vendors are advised to insure against these risks.

CANCELLATION/NO-SHOW: Any cancellation, no show or requests for changes of this contract must be made in writing and forwarded to TNLWP via email to marketplace@newlifeplace.ca . Donations made to reserve the Display Table and Exhibit Space will not be returned under any circumstances.

EXHIBITION SPACE SPECIFICATIONS: Open-space tables vary in size depending on space reserved through your donation, or the equivalent floor space. Maximum height of display from table surface is 4', and depth of display cannot exceed 5'. Utilities are not included. Exhibitor to provide all signage.

INSTALLATION AND DISMANTLING:

Setup time will begin promptly at 9:00 AM on Saturday December 2nd, 2017. Tear down will begin promptly at 5:00 PM on Saturday December 2nd, 2017.

ELECTRICITY: There are no guarantees of electrical outlets or facilities available to Vendors. Electricity is available in other parts of the vicinity and Vendors may, through prior arrangement, charge cell phones or laptop batteries, at their own convenience. Vendors are responsible for the safety of their property should they choose to utilize electricity services in other parts of the vicinity.

DISPLAY TABLE DECOR: The Vendor is encouraged to decorate their table in a manner that is appropriate and professional and in keeping with the Holiday theme of the Holiday Arts & Crafts Marketplace 2017. Merchandise must be displayed in a clean and uncluttered fashion.
